

1st KEEN Forum PhD Colloquium 2020

The first KEEN Forum PhD Colloquium is organized by consorcium of Kaunas University of Technology, Lithuania, Cranfield University, United Kingdom, University of Wuppertal, Germany, and University of St. Gallen, Switzerland, which will be held online on August 20, 2020.

Application Deadline: July 19, 2020

The KEEN Forum PhD Colloquium will provide a unique opportunity for doctoral students studying *artificiality and sustainability in entrepreneurship* to present their research and receive constructive feedback on their current research projects and guidance how to develop it further.

Under the topic of artificiality and sustainability in entrepreneurship we aim to explore past, present, and future of the adaptability of the entrepreneurs, business models and collaborative behaviours to mass digital transformation, and the ways entrepreneurship might contribute to the sustainability of the artificiality. Research might cover, however is not limited to the topics:

- Dynamics of the mind-set of entrepreneurs embracing digital transformation across different business sectors
- Dynamic entrepreneur capabilities what are they?
- · Adaptability mechanisms to facilitate sustainable growth of digital start-ups
- The effect of digital technology in start-up scaling and sustainable growth
- The dynamics of value creation and appropriation in digital start-ups across different business sectors
- Dynamics of the architectures of value-chains in digital entrepreneurship
- Sustainability if the value-chains in digital entrepreneurship
- The role of networks and different collaborative behaviours in digital entrepreneurship
- Phenomenon if the artificiality in entrepreneurship itself

Doctoral students are invited to submit abstracts describing their current research projects which are related to artificiality and sustainability in entrepreneurship. Doctoral students should be in the dissertation stage of their programs and have a relatively clear idea for their dissertation research. In order to make the conference a useful exchange forum, the Conference Committee will invite the limited number of participants to 40 and emphasize the quality and diversity of research topics. The submissions will be selected based on the double-blind review process.

An abstract proposal should contain 1,000 words. Senior researchers including PhD supervisors may be coauthors, but the students must be the lead author and present the abstract at the conference.

Please submit your abstracts as a pdf document in an anonymized form (without author/s information) via our University web site (see: https://keenforumphd.ktu.edu/#Abstract-Submission) by July 19, 2020. Please note that late submissions or submissions that do not follow the requirements will not be considered.

Selected submissions will be published in electronic proceedings of the KEEN Forum PhD Colloquium.

KEEN Forum PhD Colloquium 2020 – KEEN Best Abstract Awards

All participants in the conference are eligible for the KEEN Best Abstract Award, and doctoral students must be the presenting author of an accepted abstract and register to attend the conference. Award will be presented during the conference. All completed application to the conference are automatically entered into the Best Abstract Award 2020 competition.

Successful applicants will receive a KEEN Best Paper Award Certificate and to get an invitation to develop and submit their research work for a book entitled "Artificiality and sustainability in entrepreneurship".

The selection will be organized by the conference committee and includes several criteria such as (1) originality and theoretical foundations of the research work; (2) rigour of the proposed methodology; and (3) potential contribution and impact of the proposed work to the field.
